## Overview

DCU's Institute for International Conflict Resolution and Reconstruction (IICRR) draws on the University's deep vein of academic experience of working in and with societies affected by violent conflict. The Institute draws on Ireland's own historical experience of peace and conflict to produce internationally accessible, academically rigorous and definitive accounts of the implementation of the Northern Ireland peace process; to assist in the analysis of other conflict zones and to use international best practice to assist the remaining legacies of conflicting Ireland. The geographical scope of the Institute's work is global but focuses in particular on Northern Ireland, the post-Soviet space, the Western Balkans, Sub-Saharan Africa, South Asia and the Middle East. The Institute supports cutting edge taught programmes at BA, MA and PhD levels in the School of Law and Government and works with key civil society partners and governments so that our evidence-based knowledge is both relevant and accessible to those involved in practice.

### Research Areas

The Institute specialises in conflict resolution, post-conflict peacebuilding, and reconstruction. The Institute hosts some of Ireland's most prominent scholars in the area of international security, conflict resolution and development, as well as area experts from Eastern Europe and Western Balkans, Middle East, South Asia, and Africa.

IICRR is currently leading three major EU funded projects and a range of medium scale projects supported by the Irish Research Council, private donors and civil society organisations. We lead the largest Network of Excellence on Violent On-Line Political Extremism, looking at issues of on-line radicalisation (FP7, €6m) and two EU Marie Curie ETN PhD programmes on the post Soviet space and on the Caspian region, each worth €3.8m. The Institute regularly organises conferences, seminars and policy workshops which are open to visitors. In the last round of Irish Research Council grants two staff members won awards – focused on public protests in Iran and Gender dimension of EU peacebuilding operations in the Balkans.
